2009 and instruction issued by Directorate of Education, time to time.

With reference to your Letter No.3443 dated 05/07/2021 on the subject cited above, I am to convey the approval of Director of Education vide U.O. No.7835/DE dated 14/10/2021 for grant of extension of provisional up-gradation for Class XI and XII with Humanities and Commerce Streams for the academic sessions 2020-21 to 2024-25 in respect of your school subject, inter alia, to following conditions:-

1. Final outcome of Notification of MoUD, Govt. of India.
2. The School Authority shall submit the documentary proof regarding compliance of Section 10(1) with rule 125 of DSEAR, 1973 and submit an Undertaking in this regard within 15 days from the issue of the provisional Up-gradation.
3. The School Authority shall submit the Latest Test Report issued from Delhi Jal Board within 60 days from the date of granting of provisional up-gradation.
4. That school shall pay salary and other admissible allowances to its teaching and non-teaching staff as per on-going CPC through Bank/RTGS and not in cash.
5. The school shall comply with all the provisions of DSEAR, 1973, RTE Act, 2009, the DRTE Rules, 2011 and directions/instructions/guidelines issued by the Education Department and other Departments from time to time. The school shall also implement Orders of difference Courts/Tribunals/Statutory Authorities issued from time to time.
6. The school shall comply with the provisions of Rules 176, 177, 18(5), 17(3) & orders dated 15.12.1999, 10.05.2005, 11.02.2009, 16.04.2010 & 19.02.2016 dealing with the regulation of fee along with the subsequent orders issued by DoE time to time.
